My name is I I was a student  
 at Seneca Grade School in Seneca, IL from 1982 to 1991.  
 Beginning in the fall of 1989, when I was 12 years old, and  
 continuing for over two years, I was repeatedly sexually abused  
 by Derek Babcock. Derek Babcock was my 3<sup>rd</sup> grade teacher and  
 coach for various sports in 6<sup>th</sup> thru 8<sup>th</sup> grade. Derek Babcock started  
 "grooming" me when I was in his 3<sup>rd</sup> grade class. He told me numerous  
 times that I was going to be his babysitter when I ~~get~~ <sup>was</sup> older. Derek  
 Babcock would get me to his home under the guise of a babysitting  
 job. Derek Babcock basically told me he was ill and needed me to help  
 him sexually or he would literally die. If I told anyone about his  
 illness, he would lose his job, and it would be my fault if he lost his job.  
 The sexual abuse happened more than 50 times! Derek Babcock would have me  
 masturbate him for his own sexual gratification. One time he told me to  
 give him a "blow job", I didn't know what that meant, so he had to  
 explain it to me. I tried it, but I had braces at the time, so he settled  
 for the masturbation. At one point he played a video of his wife Lee Ann  
 masturbating while I was helping him sexually. One time during the abuse  
 I got scared by the way he was acting and told him I was going to get his wife,

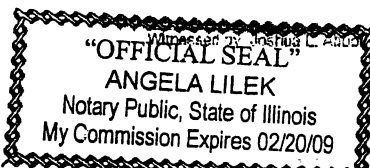

who was in their bedroom with the door closed. He grabbed me by the wrists and in a firm voice told me, "You will not bother her, she is sleeping!" On several occasions he would have letters for me telling me they were from his doctor. The letters basically told me that I needed to help him sexually because of his illness. He would make sure to take the letters as soon as I was done reading them. On just about all the occasions he would wear dark lens sunglasses w/ hot pink frames, stating he wouldn't be able to see me while I was performing the sexual acts. Most of the time while he was abusing me, his daughter would be in her crib just right down the hall. On a few occasions while driving me home from his house, he wore sweatpants and he had socks rolled up in the crotch. I asked him why he did that and he told me his doctor told him to do it because he needed to have feeling around his penis. He had a hole in the crotch of the same sweatpants (they were green) and on a few occasions he would masturbate himself while driving me home. He told me one time that his doctor told him the reason he had this "illness" is because he didn't masturbate enough when he was a teenager. I lived with this terrible secret until I was 19 years old. On October 12, 1996, I finally found the courage to let people know of the innocence this pedophile stole from me. Unfortunately, the statute of limitations had run out 52 days earlier. I was told by Randy Constantine, a La Salle County DCFS investigator that Derek had confessed to his criminal acts in a 6 page interview, but there was nothing they could do because of the statutes of limitations. It is a shame this pedophile walks away quietly and abruptly when confronted with the facts. I will do anything in my power to keep this pedophile away from innocent children. I hope you do the same. It would be a real shame to allow this pedophile back in the classroom. Please feel free to contact me if I can be of any further assistance.
